The Excellence in Education Award is jointly sponsored by OSSTF District 11 and the Thames Valley District School Board.

The nominees for this award can be put forward by a Bargaining Unit, a School Awards Committee or any member of OSSTF District 11 in good standing. Please note that all nominations **must** be received at the OSSTF District 11 office by the nomination deadline. Recipients for the award will be chosen by the OSSTF District 11 Awards Committee. While all nominations received by the deadline will be considered, only the successful recipients of the award will be contacted by the District Office.

Up to 35 recipients across District 11 can receive the Excellence in Education Award. It is possible to have more than a single recipient from a specific school/work site or bargaining unit. A member from one bargaining unit (TBU, PSSP, CEI, OT) can nominate a member from a different bargaining unit that works at a different location.

Recipients will be contacted by the District Office with further information about the awards ceremony. Please note that attendance for the awards ceremony is limited to recipients, a guest of their choice, their Principal/Supervisor and other VIP invitees of OSSTF District 11 and the TVDSB.

The ceremony and reception will be held on **Thursday, March 30th, 2023** at the Best Western Lamplighter Inn.

Who May Nominate?

- Any OSSTF/FEESO District 11 member in good standing
- A Bargaining Unit such as the Teachers' Bargaining Unit (TBU), Professional Student Services Personnel (PSSP), Occasional Teachers' (OT), Continuing Education Instructors (CEI) and Continuing Education Teachers (CET)
- School Awards Committee

Who May Be Nominated?

- Any OSSTF/FEESO District 11 member. Preference will be given by the selection committee for OSSTF/FEESO District 11 members with a minimum of 5 years education experience.
- The nominee must be currently employed by the TVDSB.
- The nominee should not have been a previous recipient.

Nominations Process:

- Fill out the Nomination Application and complete the Nominee Profile. Scan and send to the District Office by the nomination deadline.
- While not a requirement, it is recommended that up to TWO letters of recommendation in support of the nominee be submitted by the nomination deadline.

- Motivates others to acquire a life-long interest in learning.
